Interested eligible bidders may obtain further information on the bidding process and collect the bidding documents for the tender item from the office of Project Director (ASR), Board of Revenue, Government of Sindh, adjacent Dr. Ziauddin Hospital, Clifton, Karachi, Tel: +92-21-99251367-68 / Fax: +92-21-35305586 from the date of publication during office hours, i.e. from Monday to Thursday (10:00 am to 4:00 pm) & on Friday (10:00 am to 01:00 pm) on payment of document fee of Rs. 3,000/- (non-refundable) for the tender item separately in the form of Pay order/Demand Draft in favor of Project Director (ASR), Board of Revenue, Sindh till 12:00noon on Monday, October 10, 2022. Further information / clarifications may also be obtained from the same office.

2. The bidding document can also be downloaded from the website of SPPRA, i.e. [www.pprasindh.gov.pk](http://www.pprasindh.gov.pk) and <https://ppms.pprasindh.gov.pk> or the website of BOR, i.e. <https://bor.sindh.gov.pk>, in which case document fee must be submitted along with the bid. Only the bids submitted with the document fee will be considered as eligible for participation in the bidding process.

3. Tender Bids shall comprise a single package containing two separate envelopes. Each envelope shall contain separately the financial proposal and the technical proposal, be marked as "FINANCIAL PROPOSAL" and "TECHNICAL PROPOSAL" in bold and legible letters to avoid confusion; against the tender item along with bid security of the quoted



amount of the total bid in the form of Deposit at Call or Pay Order or Demand Draft or a Bank Guarantee issued by a scheduled bank in Pakistan; which should be dropped / submitted at the office of the Project Director (ASR), Board of Revenue, Government of Sindh, adjacent Dr. Ziauddin Hospital, Clifton, Karachi, Tel: +92-21-99251367-68 / Fax: +92-21-35305586, on or before 02:00 pm on Monday, October 10, 2022. Further information / clarification may also be obtained in the same office.

4. The proposals submitted against the subject RFP will be opened by the Procurement Committee on same day, i.e. 02:30 pm on Monday, October 10, 2022 in the Committee room of Office of LARMIS, Board of Revenue, Government of Sindh, adjacent Dr. Ziauddin Hospital, Clifton, Karachi, Tel: +92-21-99251367-68 / Fax: +92-21-35305586 in presence of all the bidders, or their representatives, who may choose to be present.

5. All bids received will be opened and evaluated in the manner prescribed in the evaluation criteria of bidding document in accordance with Single Stage - Two Envelop procedure under SPP Rules 2010.

6. Only bids offered on the prescribed tender form issued by the office of the Project Director (ASR), Board of Revenue, Government of Sindh, shall be accepted. However, additional sheets may be attached, if necessitated.

7. Conditional tender / application will not be entertained.

8. Project Management Unit, Board of Revenue Sindh may cancel the bidding process at any time prior to the acceptance of a bid or proposal under Rule 25 (1) of SPP Rules 2010."

9. Procuring agencies shall announce the results of bid evaluation in the form of a report giving reasons for acceptance or rejection of bids. The report shall be hoisted on website of the Authority.
